FOREWORD

This Malaysian Standard was developed by the Technical Committee on Pallets under the authority of the Industry Standards Committee on Packaging and Distribution.

This Malaysian Standard is the second revision of MS 1174, *Specification for large wooden pallets for through transit of goods*.

Major modifications in this revision are as follows:

- a) the title has been changed from "*Specification for large wooden pallets for through transit of goods*" to "*Large wooden pallets - Principal dimensions and tolerances*";
- b) in Table 1, the tolerance on the nominal size has been added;
- c) in Table 1, the size code of pallets, "D" and "E" have been deleted;
- d) in Table 2, the value of maximum width ($w_{1\max}$) has been changed from "175 mm" to "75 mm";
- e) in Figure 1, the figure on diagrammatic arrangement of openings has been replaced; and
- f) incorporation of new clause on marking.

This Malaysian Standard cancels and replaces MS 1174:2000.
